addresses of Users;

"Intellectual Property

Rights"

patents, rights to inventions, copyright and related rights, trade marks, business names and domain names, rights in get-up, goodwill and the right to sue for passing off, rights in designs, database rights, rights to use, and protect the confidentiality of, confidential information (including knowhow), and all other intellectual property rights, in each case whether registered or unregistered and including all applications and rights to apply for and be granted, renewals or extensions of, and rights to claim priority from, such rights and all similar or equivalent rights or forms of protection which subsist or will subsist

now or in the future in any part of the world;

the Customer's order for Services as "Order' set out in the form attached to these

Conditions:

"Renewal Period" as defined in clause 4.1;

"Services"

2 Interpretation

The following rules of interpretation apply in these Conditions.

2.1 A reference to legislation or a legislative provision:

- 2.1.1 is a reference to it as amended, extended or re-enacted from time to time; and
- shall include all subordinate legislation made from time to 2.1.2 time under that legislation or legislative provision.
- Any words following the terms including, include, in particular, for 2.2 example or any similar expression, shall be construed as illustrative and shall not limit the sense of the words, description, definition, phrase or term preceding those terms.
- 2.3 A reference to writing or written includes email.

3 Basis of contract

- Any samples, descriptive matter or advertising issued by the Supplier, 3.1 and any descriptions or illustrations on the Website or published for the sole purpose of giving an approximate idea of the Services described in them shall not form part of the Contract or have any contractual force.
- 3.2 These Conditions apply to the Contract to the exclusion of any other terms that the Customer seeks to impose or incorporate, or which are implied by law, trade custom, practice or course of dealing.

4 Contract Duration

- The Contract shall commence on the Start Date and continue for an initial period of six months (the "Trial Period") at which point it shall automatically renew for successive periods of 12 months (each a "Renewal Period") unless terminated earlier:
 - 4.1.1 in accordance with clause 14;
 - 4.1.2 by the Supplier for convenience on providing the Customer with not less than 30 days' prior written notice, such notice to expire after the end of the Trial Period:
 - by the Customer at any time during the Trial Period by 4.1.3 requesting from the Supplier a STOP CODE. The Customer must request the STOP CODE at least 1 day prior to the expiry of the Trial Period and obtaining it shall terminate the Contract at the end of the Trial Period;
 - by the Customer any time during a Renewal Period by requesting from the Supplier a STOP CODE. The Customer 4.1.4 must request the STOP CODE at least 1 day prior to the expiry of the Renewal Period and obtaining it shall terminate the Contract at the end of the current Renewal Period.

The Customer must obtain a STOP CODE from going to www.ukbride.co.uk/stop and following the instructions.

4.2 If the Customer fails to obtain the STOP CODE in accordance with clause 4.1 the Contract will continue for the next Renewal Period and the Customer will be responsible for the payment of the Charges for such Renewal Period.

5 Supply of Services

- The Supplier shall supply the Services to the Customer in accordance 5.1 with the Campaign in all material respects.
- 5.2 The Supplier reserves the right to amend the Campaign if necessary, to comply with any applicable law or regulatory requirement, or if the amendment will not materially affect the nature or quality of the Services, and the Supplier shall notify the Customer in any such event.
- The Supplier warrants to the Customer that the Services will be 5.3 provided using reasonable care and skill.
- The Services are intended for use in connection with business-to-5.4 consumer marketing only. The Customer agrees that the Customer will only use the Services for purposes relating to business-toconsumer marketing.
- 5.5 The Supplier does not give any representations, warranties, conditions, undertakings, or terms (either expressed or implied):
 - 5.5.1 as to the fitness for a particular purpose of the Services and/or the Information;
 - that the Services and/or Information will meet the 5.5.2 Customer's requirements; or
 - 5.5.3 that provision of the Services will be uninterrupted, timely, secure or error free.
- 5.6 The Customer acknowledges that the Supplier does not guarantee any results from Advertising, use of Supplier publications, use of the Information or use of the Website.
- The Supplier will use reasonable endeavours to ensure that this 5.7 Website is normally available 24 hours a day, but the Supplier will not be liable if the Website is unavailable as access to the Website may be suspended temporarily and without notice in the case of system failure, maintenance or repair or for reasons beyond the Supplier's control.

6 Advertising

6.1 This clause 6 shall apply where the Services include Advertising.

- 6.2 shall be required to comply with and shall be subject to the Website technical requirements or specifications as notified by the Supplier to the Customer from time to time. The Supplier has right to refuse content that it reasonably determines is illegal, offensive or inappropriate.
- 6.3 The Customer's right to display content on the Website is nonexclusive and the Supplier shall be entitled to display similar third party promotional material on the Website, which may relate to direct competitors of the Customer.
- 6.4 In the event of any content being published incorrectly, where the Supplier is solely responsible, the Supplier will display replacement content of an equivalent level, free of charge to the Customer. This will be the sole remedy of the Customer and the Customer will not be entitled to any refund of Charges in respect of such incorrect publication.

7 Information

- 7.1 This clause 7 shall apply where the Services include the provision of Information.
- 7.2 The Customer agrees that it may only use the Information during the term of the Contract or such period as is specified in the Order.
- 7.3 The Customer acknowledges that any usage of any Information outside of what has been agreed with the Supplier will result in further Charges.
- 7.4 Clause 7.2 shall not restrict the Customer from using the Information where a data subject becomes a bona fide customer of the Customer as a result of the Customer's use of the Information in accordance with the Contract.
- 7.5 The Customer will use the Information in accordance with all relevant codes of practice in the direct marketing industry and/or the advertising industry and any other applicable laws.
- 7.6 The Customer shall screen telephone numbers in the Information against the Telephone Preference Service ("TPS") and Corporate TPS ("CTPS"). If a telephone number is listed on either service the Customer agrees that it will not make marketing calls to that number, unless the data subject has specifically consented to receive the Customer's calls.
- 7.7 Where we provide the contact details of brides-to-be they have consented (and not withdrawn their consent) to the Customer using those contact details in accordance with these Conditions. The Customer undertakes to comply with the rules on Telephone Marketing at <a href="https://ico.org.uk/for-organisations/quide-topecr/electronic-and-telephone-marketing/telep
- 7.8 The Information may contain a number of check names, telephone and addresses ("Seeded Data") in order to monitor the usage of Information by the Customer and to ensure that it is used in accordance with this Contract.
- 7.9 Without limiting any other right or remedy that the Supplier may have, where the Information is used after the date on which a STOP code requested under clause 4.1 takes effect the Supplier shall be entitled to invoice and the Customer shall pay a sum equal to the Charges which would have been due in respect of the current Renewal Period had the STOP code not been requested (which sum shall be payable within thirty days of the date on which the Customer receives the Supplier's invoice for such sum).
- 7.10 The Customer acknowledges and agrees that it is solely responsible for any actions taken by the Customer on the basis of the Information.
- 7.11 The Customer further acknowledges that the Information may include information inputted by a third party and that the Supplier is not responsible for the accuracy of such Information.
- 7.12 When using the Information, the Customer is not permitted to say that it is an affiliate of the Supplier or that the Customer has been recommended by the Supplier (unless the Supplier has specifically agreed to this in writing).

8 Customer's general obligations

- 8.1 The Customer shall:
 - 8.1.1 ensure that the terms of the Order are complete and
 - 8.1.2 co-operate with the Supplier in all matters relating to the Services;
 - 8.1.3 provide the Supplier with such information and materials as the Supplier may reasonably require in order to supply the Services, and ensure that such information is complete and accurate in all material respects;
 - 8.1.4 obtain and maintain all necessary licences, permissions and consents which may be required for the Services before the date on which the Services are to start;
 - 8.1.5 comply with any additional obligations as detailed in the Campaign.
- 8.2 If the Supplier's performance of any of its obligations under the Contract is prevented or delayed by any act or omission by the

- Customer or failure by the Customer to perform any relevant obligation ("Customer Default"):
 - without limiting or affecting any other right or remedy available to it, the Supplier shall have the right to suspend performance of the Services until the Customer remedies the Customer Default, and to rely on the Customer Default to relieve it from the performance of any of its obligations in each case to the extent the Customer Default prevents or delays the Supplier's performance of any of its obligations;
- 8.2.2 the Supplier shall not be liable for any costs or losses sustained or incurred by the Customer arising directly or indirectly from the Supplier's failure or delay to perform any of its obligations as set out in this clause 8.2; and
- 8.2.3 the Customer shall reimburse the Supplier on written demand for any costs or losses sustained or incurred by the Supplier arising directly or indirectly from the Customer Default.

9 Charges and payment

- 7.1 The annual Charges for the Services in each Renewal Period are determined by the Campaign selected by the Customer in the Order as follows:
 - Bronze: £599 + VAT
 - Silver £999 + VAT
 - Gold £1,599 + VAT
 - Platinum £1,999 + VAT
- 9.2 The Supplier reserves the right to increase the Charges for any Renewal Period upon providing the Customer at least 60 days' notice.
- 9.3 The Supplier shall invoice the Customer for the Charges for the applicable Renewal Period on or around the commencement of that Renewal Period.
- 9.4 The Customer shall pay each invoice submitted by the Supplier:
 - 9.4.1 within 7 days of the date of the invoice or in accordance with any credit terms agreed by the Supplier and confirmed in writing to the Customer; and
 - 9.4.2 in full and in cleared funds to a bank account nominated in writing by the Supplier, and time for payment shall be of the essence of the Contract.
- 9.5 All amounts payable by the Customer under the Contract are exclusive of amounts in respect of value added tax chargeable from time to time ("VAT"). Where any taxable supply for VAT purposes is made under the Contract by the Supplier to the Customer, the Customer shall, on receipt of a valid VAT invoice from the Supplier, pay to the Supplier such additional amounts in respect of VAT as are chargeable on the supply of the Services at the same time as payment is due for the supply of the Services.
- 9.6 If the Customer fails to make a payment due to the Supplier under the Contract by the due date, then, without limiting the Supplier's remedies under clause 14, the Customer shall pay interest on the overdue sum from the due date until payment of the overdue sum, whether before or after judgment. Interest under this clause 9.6 will accrue each day at 8% a year above the Bank of England's base rate from time to time, but at 8% a year for any period when that base rate is below 0% and the Supplier shall be entitled to recover from the Customer all costs (including legal costs) incurred by the Supplier in recovering payment from the Customer.
- 9.7 All amounts due under the Contract shall be paid in full without any set-off, counterclaim, deduction or withholding (other than any deduction or withholding of tax as required by law).

10 Intellectual property rights

- 10.1 All Intellectual Property Rights in or arising out of or in connection with the Services (other than Intellectual Property Rights in any materials provided by the Customer) shall be owned by the Supplier.
- 10.2 The Customer grants the Supplier a fully paid-up, non-exclusive, royalty-free, non-transferable licence to copy and modify any materials provided by the Customer to the Supplier for the term of the Contract for the purpose of providing the Services.

11 Data protection

- 11.1 The parties shall comply with their data protection obligations as set out in Schedule 1.
- 12 Limitation of liability
- 12.1 References to liability in this clause 12 include every kind of liability arising under or in connection with the Contract including liability in contract, tort (including negligence), misrepresentation, restitution or otherwise.
- 12.2 Nothing in this clause 12 shall limit the Customer's payment obligations under the Contract or any liability arising under the indemnity in clause 13.
- 12.3 Nothing in the Contract limits any liability which cannot legally be limited, including but not limited to liability for:
 - 12.3.1 death or personal injury caused by negligence; and12.3.2 fraud or fraudulent misrepresentation.
- 12.4 Subject to clause 12.3, the Supplier's total liability to the Customer for all loss or damage shall not exceed 100% of the Charges paid or payable by the Customer for the Services in the 12 months preceding

the date of the claim.

- 12.5 Subject clause 12.2 and clause 12.3, this clause 12.5 sets out the types of loss that are wholly excluded:
 - 12.5.1 loss of profits.
 - 12.5.2 loss of sales or business.
 - 12.5.3 loss of agreements or contracts.
 - 12.5.4 loss of anticipated savings.
 - 12.5.5 loss of use or corruption of software, data or information.
 - 12.5.6 loss of or damage to goodwill; and
 - 12.5.7 indirect or consequential loss.
- 12.6 The terms implied by sections 3 and 5 of the Supply of Goods and Services Act 1982 are, to the fullest extent permitted by law, excluded from the Contract.
- 12.7 Unless the Customer notifies the Supplier that it intends to make a claim in respect of an event within the notice period, the Supplier shall have no liability for that event. The notice period for an event shall start on the day on which the Customer became, or ought reasonably to have become, aware of the event having occurred and shall expire 6 months from that date. The notice must be in writing and must identify the event and the grounds for the claim in reasonable detail.
- 12.8 This clause 12 shall survive termination of the Contract.

13 Indemnity

The Customer shall indemnify the Supplier and the Supplier's officers, directors, employees and agents from and against all claims, liability, damages, losses, costs (including legal fees) arising out of any breach of the Conditions by the Customer.

14 Termination

- 14.1 Without affecting any other right or remedy available to it, either party may terminate the Contract with immediate effect by giving written notice to the other party if:
 - 14.1.1 the other party commits a material breach of any term of the Contract and (if such a breach is remediable) fails to remedy that breach within 30 days of that party being notified in writing to do so;
 - 14.1.2 the other party takes any step or action in connection with its entering administration, provisional liquidation or any composition or arrangement with its creditors (other than in relation to a solvent restructuring), applying to court for or obtaining a moratorium under Part A1 of the Insolvency Act 1986, being wound up (whether voluntarily or by order of the court, unless for the purpose of a solvent restructuring), having a receiver appointed to any of its assets or ceasing to carry on business;
 - 14.1.3 the other party suspends, or threatens to suspend, or ceases or threatens to cease to carry on all or a substantial part of its business; or
 - the other party's financial position deteriorates to such an extent that in the terminating party's opinion the other party's capability to adequately fulfil its obligations under the Contract has been placed in jeopardy.
- 14.2 Without affecting any other right or remedy available to it, the Supplier may terminate the Contract with immediate effect by giving written notice to the Customer if the Customer fails to pay any amount due under the Contract on the due date for payment.
- 14.3 Without affecting any other right or remedy available to it, the Supplier may suspend the supply of Services under the Contract or any other contract between the Customer and the Supplier if:
 - 14.3.1 the Customer fails to pay any amount due under the Contract on the due date for payment;
 - 14.3.2 the Customer becomes subject to any of the events listed in clause 14.1.2 or clause 14.1.3, or the Supplier reasonably believes that the Customer is about to become subject to any of them; and
 - 14.3.3 the Supplier reasonably believes that the Customer is about to become subject to any of the events listed in clause 14.1.

15 Consequences of termination

- 15.1 On termination of the Contract:
 - 15.1.1 the Customer shall immediately pay to the Supplier all of the Supplier's outstanding unpaid invoices and interest and, in respect of Services supplied but for which no invoice has been submitted, the Supplier shall submit an invoice, which shall be payable by the Customer immediately on receipt;
 - 15.1.2 no refunds shall be paid for any Charges paid in advance by the Customer; and
 - 15.1.3 any licence or permission granted to the Customer will cease immediately including login rights.
- 15.2 Termination of the Contract shall not affect any rights, remedies, obligations or liabilities of the parties that have accrued up to the date of termination, including the right to claim damages in respect of any breach of the Contract which existed at or before the date of termination.

15.3 Any provision of the Contract that expressly or by implication is intended to come into or continue in force on or after termination of the Contract shall remain in full force and effect.

16 Privacy Policy

All personal data collected from the Customer shall be processed in accordance with the Supplier's Privacy Policy at www.ukbride.co.uk/privacy-policy.

17 General

17.1 Force majeure

Neither party shall be in breach of the Contract nor liable for delay in performing, or failure to perform, any of its obligations under the Contract if such delay or failure result from events, circumstances or causes beyond its reasonable control including, without limitation: acts of God, flood, drought, earthquake or other natural disaster; epidemic or pandemic; terrorist attack, civil war, civil commotion or riots, war, threat of or preparation for war, armed conflict, imposition of sanctions, embargo, or breaking off of diplomatic relations; nuclear, chemical or biological contamination or sonic boom; any law or any action taken by a government or public authority; collapse of buildings, fire, explosion or accident; and interruption or failure of utility service.

17.2 Assignment and other dealings

- 17.2.1 The Supplier may at any time assign, mortgage, charge, subcontract, delegate, declare a trust over or deal in any other manner with any or all of its rights and obligations under the Contract.
- 17.2.2 The Customer shall not assign, transfer, mortgage, charge, subcontract, delegate, declare a trust over or deal in any other manner with any of its rights and obligations under the Contract without the prior written consent of the Supplier.

17.3 Confidentiality

- 17.3.1 Each party undertakes that it shall not at any time during the Contract, and for a period of two years after termination of the Contract, disclose to any person any confidential information concerning the business, affairs, customers, clients or suppliers of the other party, except as permitted by clause 17.3.2.
- 17.3.2 Each party may disclose the other party's confidential information:
 - (a) to its employees, officers, representatives, contractors, subcontractors or advisers who need to know such information for the purposes of carrying out the party's obligations under the Contract. Each party shall ensure that its employees, officers, representatives, contractors, subcontractors or advisers to whom it discloses the other party's confidential information comply with this clause 17.3; and
 - (b) as may be required by law, a court of competent jurisdiction or any governmental or regulatory authority.

17.4 Entire agreement

- 17.4.1 The Contract constitutes the entire agreement between the parties and supersedes and extinguishes all previous agreements, promises, assurances, warranties, representations and understandings between them, whether written or oral, relating to its subject matter.
- 17.4.2 Each party acknowledges that in entering into the Contract it does not rely on, and shall have no remedies in respect of, any statement, representation, assurance or warranty (whether made innocently or negligently) that is not set out in the Contract. Each party agrees that it shall have no claim for innocent or negligent misrepresentation based on any statement in the Contract.

17.5 Variation

Except as set out in these Conditions, no variation of the Contract shall be effective unless it is in writing and signed by the parties (or their authorised representatives).

17.6 Waiver

A waiver of any right or remedy under the Contract or by law is only effective if given in writing and shall not be deemed a waiver of any subsequent right or remedy. A failure or delay by a party to exercise any right or remedy provided under the Contract or by law shall not constitute a waiver of that or any other right or remedy, nor shall it prevent or restrict any further exercise of that or any other right or remedy. No single or partial exercise of any right or remedy provided under the Contract or by law shall prevent or restrict the further exercise of that or any other right or remedy.

17.7 Severance

If any provision or part-provision of the Contract is or becomes invalid, illegal or unenforceable, it shall be deemed deleted, but that shall not affect the validity and enforceability of the rest of this agreement. If any provision or part-provision of this Contract deleted under this clause 17.7 the parties shall negotiate in good faith to agree a replacement

provision that, to the greatest extent possible, achieves the intended commercial result of the original provision.

17.8 Notices

- 17.8.1 Any notice given to a party under or in connection with the Contract shall be in writing and shall be delivered by hand or by pre-paid first-class post or other next working day delivery service at its registered office (if a company) or its principal place of business (in any other case); or sent by email to the address specified in the Order.
- 17.8.2 Any notice shall be deemed to have been received:
- 17.8.3 if delivered by hand, at the time the notice is left at the proper address;
- 17.8.4 if sent by pre-paid first-class post or other next working day delivery service, at 9.00 am on the second Business Day after posting; or
- 17.8.5 if sent by email at the time of transmission, or, if this time falls outside business hours in the place of receipt, when business hours resume. In this clause 17.8.2(c), business hours means 9.00am to 5.00pm Monday to Friday on a day that is not a public holiday in the place of receipt.
- 17.8.6 This clause 17.8 does not apply to the service of any proceedings or other documents in any legal action or, where applicable, any other method of dispute resolution.

17.9 Third Party Rights

Unless it expressly states otherwise, the Contract does not give rise to any rights under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of the Contract.

17.10 Governing Law

The Contract, and any dispute or claim (including noncontractual disputes or claims) arising out of or in connection with it or its subject matter or formation shall be governed by and construed in accordance with the law of England and Wales.

17.11 Jurisdiction

Each party irrevocably agrees that the courts of England and Wales shall have exclusive jurisdiction to settle any dispute or claim (including non-contractual disputes or claims) arising out of or in connection with the Contract or its subject matter or formation provided that either party may enforce any judgment of the courts of England and Wales in the courts of any jurisdiction.

Schedule 1 Whitespace Publishers Limited Terms and Conditions for the provision of Services Data Protection

1 Definitions

"Agreed Purposes"

as set out in the Order;

"Controller", "processor", "data subject", "personal data", "personal data breach", "processing" and "appropriate technical and organisational measures"

as set out in the UK Data Protection Legislation in force at the time;

"Data Discloser"

a party that discloses Shared Personal Data to the other party;

"UK Data Protection Legislation"

all applicable data protection and privacy legislation in force from time to time in the UK including the Data Protection Act 2018 (DPA); and the Privacy and Electronic

Communications Regulations 2003 (SI 2003/2426) as amended;

"Permitted Recipients"

the parties to this agreement, the employees of each party, any third parties engaged to perform obligations in connection with this agreement:

"Shared Personal Data"

the personal data to be shared between the parties under clause 1.1 of this schedule.

Data Protection

1.1 Shared Personal Data

- (a) This clause sets out the framework for the sharing of personal data between the parties as controllers. Each party acknowledges that one party (referred to in this clause as the Data Discloser) will regularly disclose to the other party Shared Personal Data collected by the Data Discloser for the Agreed Purposes.
- (b) Effect of non-compliance with UK Data Protection Legislation. Each party shall comply with all the obligations imposed on a controller under the UK Data Protection Legislation, and any material breach of the UK Data Protection Legislation by one party shall, if not remedied within 30 days of written notice from the other party, give grounds to the other party to terminate this agreement with immediate effect.
- (c) Particular obligations relating to data sharing. Each party shall:
 - ensure that it has all necessary notices and consents in place to enable lawful transfer of the Shared Personal Data to the Permitted Recipients for the Agreed Purposes;
 - (ii) give full information to any data subject whose personal data may be processed under this agreement of the nature such processing. This includes giving notice that, on the termination of this agreement, personal data relating to them may be retained by or, as the case may be, transferred to one or more of the Permitted Recipients, their successors and assignees;
 - (iii) process the Shared Personal Data only for the Agreed Purposes;
 - (iv) not disclose or allow access to the Shared Personal Data to anyone other than the Permitted Recipients;
 - ensure that all Permitted Recipients are subject to written contractual obligations concerning the Shared Personal Data (including obligations of confidentiality) which are no less onerous than those imposed by this agreement;
 - (vi) ensure that it has in place appropriate technical and organisational measures, reviewed and approved by the other party, to protect against unauthorised or unlawful processing of personal data and against accidental loss or destruction of, or damage to, personal data.
 - (vii) not transfer any personal data received from the Data Discloser outside the UK unless the transferor:
 - (A) complies with the provisions of the DPA (in the event the third party is a joint controller); and
 - (B) ensures that (i) the transfer is to a country approved by the UK Government as providing adequate protection pursuant to the DPA; or (ii)

there are appropriate safeguards in place pursuant to the DPA; or (iii) Binding corporate rules are in place; or

(viii) one of the derogations for specific situations in the DPA applies to the transfer.

1.2 Mutual assistance

- (d) Each party shall assist the other in complying with all applicable requirements of the UK Data Protection Legislation. In particular, each party shall:
 - (i) consult with the other party about any notices given to data subjects in relation to the Shared Personal Data;
 - promptly inform the other party about the receipt of any data subject access request;
 - (iii) provide the other party with reasonable assistance in complying with any data subject access request;
 - (iv) not disclose or release any Shared Personal Data in response to a data subject access request without first consulting the other party wherever possible;
 - (v) assist the other party, at the cost of the other party, in responding to any request from a data subject and in ensuring compliance with its obligations under the UK Data Protection Legislation with respect to security, personal data breach notifications, data protection impact assessments and consultations with supervisory authorities or regulators;
 - (vi) notify the other party without undue delay on becoming aware of any breach of the UK Data Protection Legislation;
 - (vii) at the written direction of the Data Discloser, delete or return Shared Personal Data and copies thereof to the Data Discloser on termination of this agreement unless required by law to store the personal data;
 - (viii) use compatible technology for the processing of Shared Personal Data to ensure that there is no lack of accuracy resulting from personal data transfers;
 - (ix) maintain complete and accurate records and information to demonstrate its compliance with this Schedule 1; and
 - (x) provide the other party with contact details of at least one employee as point of contact and responsible manager for all issues arising out of the UK Data Protection Legislation, including the joint training of relevant staff, the procedures to be followed in the event of a data security breach, and the regular review of the parties' compliance with the UK Data Protection Legislation.
